Thank you for considering making a donation to the Hurst Water Meadow Trust. We depend upon the generosity of people like you to preserve and maintain the water meadows for this and for future generations. We welcome both regular standing orders and one-off donations.

Regular donation via standing order

If you wish to make a standing order, please complete the attached standing order mandate form and send the top part to your bank and the bottom part to the Treasurer of the Hurst Water Meadow trust (address at the bottom of the form). Alternatively, you might wish to set this up using on-line banking in which case you only need to send the bottom part to us so that we can keep our records up to date and ensure that we are receiving the amounts in accordance with your instructions.

One-off donation

You can make a one-off donation via cheque or bank transfer. Our account details are given on the standing order mandate form. Again, we would be grateful if you could return the bottom half of the form to us for our records.

Gift Aid

Whether you wish to make a regular or a one-off gift, we would also ask that you consider making a Gift Aid declaration. Gift Aid is an income tax relief designed to benefit charities. If you're a UK taxpayer, Gift Aid increases the value of your charity donations by 25% because the charity can reclaim the basic rate of tax on your gift at no extra cost to you. The completed form should be sent to the Treasurer of the Trust. Your address is needed to identify you as a current UK taxpayer.

Information given on the forms is solely for the purposes of maintaining the necessary records for the Trust. We will not share or distribute your information to other organisations.
